VETERINARY NURSE INITIATIVE UPDATE JULY 2018

OAVT sends out a huge thank you and much appreciation to all of those who stepped up with their show of support for the Veterinary Nurse Initiative (VNI) by making phone calls and/or sending e-mails to your local representatives in the Ohio State House of Representatives. We have come a long way and have had great success!

HB501 is the bill for the name change of Registered Veterinary Technician to Registered Veterinary Nurse in Ohio. With the gracious help of the OVMA, The Ohio State University School of Veterinary Medicine, and Columbus State Community College we were able to

pass over the first hurdle with a favorable pass in the Agriculture Committee of the House of Representatives in order to go to the main floor of the House. Several OAVT board members, veterinarians and staff members took time out of their schedules to come to the State House to stand up for technicians in a show of solidarity and gave witness testimony to the critical importance of our profession as well as the skill set and knowledge base required daily.

After our supporters gave favorable testimony the Nursing Association was allowed to give their testimony as well, which required an additional day of testimony at the State House. After members of the Agriculture Committee heard both sides of testimony they agreed almost unanimously and voted 14-1 in favor of changing the title to Registered Veterinary Nurse and gave allowance for HB501 to head to the floor for final approval by The House of Representatives.

At this point we are waiting on the House to reconvene for our bill to hopefully make it to the floor in August. The Speaker of the House stepped down in April which required the House to approve a new speaker. This process caused some delay and then there was a break over the Easter holiday. The House held additional sessions in an effort to catch up but we were not successful in getting into that docket list. The House is currently on a short summer break and will come back together in August.

The OAVT needs your support more so than ever once the House reconvenes. If we cannot get the bill to come to the Floor in August we will have to start the process from the beginning as the bill will have timed out. We will be sending out a Call to Action as soon as we have a date for the House. We ask all of you, your family, and friends to once again reach out to your representatives (both at home and where you work if different districts) with a phone call or e-mail showing the importance of this bill and the importance of what we do. We have come so far but have a little more to do.
