In Memory Of Jayne L. White, RVT September 20, 1947 - May 29, 2008

Jayne L. White, age 60, of Canton, died Thursday, May 29, 2008 at University Hospital, Cleveland, Ohio. She was a 1965 graduate of Dalton High School and earned an Associates Degree from Columbus Community College, a Bachelor's Degree from Mount Vernon Nazarene College and a Master's Degree from Ashland University.

She was employed as office manager for the Great Lakes Veterinary Specialists of Bedford, OH and was a part-time instructor in Veterinary Technology at the Tuscarawas Campus of Kent State University.

Jayne has been an RVT for over 30 years. Jayne started out as an owner-trainer of Standardbreds for nearly 20 years and then worked as a veterinary technician and eventually managed several veterinary hospitals. She was active in the Stark County Humane Society and served as a foster home for pets displaced by Hurricane Katrina. She contributed her life to the care of animals. She was an asset to the veterinary technology program and will be sadly missed by all who knew her.
